Sunday Keynote Is Your Head in the Clouds?

Ms. Friedman will discuss the various legal implications of using cloud environments, which are too often overlooked because of convenience and short-term cost savings. She will underscore the crucial role of RIM in cloud environments and how RIM professionals can begin a dialogue so that the heads of each of four key groups — RIM, IT, Legal and Compliance — get into the clouds, where they belong. Ms. Friedman is the current chair of the steering committee of Sedona Canada, the non-profit group responsible for the electronic discovery principles which are incorporated by reference into the Ontario Rules of Civil Procedure. In 2011, Ms. Friedman was named one of the "Top 25 Most Influential Lawyers in Canada".
